## Wednesday, December 11, 2024 MEETING MINUTES

1. Call to order.

Meeting was called to order at 6:00 p.m. by President Matt Bland.

2. Establish a quorum.

Randy Schott moved to elect Wes Robinson as President of the Board. 2nd: Matt Bland Vote: four in favor (Schott, Robinson, Ward, and Bland), two against (Palmer and Gaines), with one abstention (Menley)
Motion passes.

Robinson moved to elect Blake Ward as Vice-President. 2<sup>nd</sup>: Matt Bland Vote: Six in favor (Robinson, Bland, Schott, Ward, Gaines, and Palmer) with one abstention (Menley); motion passes.

Gaines moved to elect Matt Bland as Secretary. 2nd: Randy Schott Vote: Six in favor (Gaines, Schott, Robinson, Bland, Ward, and Palmer) with one abstention (Menley); motion passes.

- 6. Approve minutes from the November 2024 regular meeting.

  Vote: 5-0 with two abstentions (Palmer & Menley)

9. Discussion/Possible Action: Invoices Received and Invoices Paid for December. Motion to approve the invoices as presented: Matt Bland 2nd: Randy Schott Vote: 6-0 with one abstention (Menley) Motion passes.

10. Review TWDB Drought Index and other monitoring sites. Jim Burton explained the report and answered questions.

11. Discussion/Possible Action: Kinney County Appraisal District offer by Charlena Cavender to purchase "trust property" UN 1 Lot 254.

Motion by Charlie Gaines to accept the offer. 2nd: Wes Robinson

Vote: five in favor (Gaines, Schott, Robinson, Ward, and Palmer) with one abstention (Menley) and one absent (Bland).

Motion passes.

12. Discussion/Possible Action: Proposed draft rule amendments and call a public hearing.

Motion by Charlie Gaines to approve the draft rule amendments for publication and call a public hearing on January 8 at 5:30 p.m. before the regular board meeting. 2nd: David Palmer

Vote: three in favor (Gaines, Schott, and Palmer), two against (Robinson and Schott), one abstention (Ward), and one absent (Bland).

Motion fails.

[Director Matt Bland again present.]

13. Discussion/Possible Action: Approval of signatories for all bank accounts. Charlie Gaines moved to approve all current Board members as signatories along with the general manager but exclude Perry Menley (who did not wish to be included). 2nd: Matt Bland Vote: 6-0 with one abstention (Menley) Motion passes.

## 14. General Manager's Report.

General Manager G. Hobbs gave her report, including that the district had received eight exempt well applications since last January and that the auditors have almost completed the overdue audits and are waiting on paperwork from the banks.
